I further understand and agree that ZBC has no responsibility to pay medical treatment of any kind if said child suffers injury, harm, or loss during the activities.

Knowing the risks described herein, I agree personally and in behalf of the Minor Child, assume and waive all risks and responsibilities surrounding Minor Child’s participation in the ACTIVITY. I further agree to hold harmless, release, and indemnify ZBC, her officers, trustees, staff, volunteers, employees, and agents, from and against any present or future claims, causes of action, loss or liability for injury to person or property, medical bills and expenses of any kind to the extent allowed by law for which the Minor Child may suffer as a result of his/her participation in the ACTIVITY regardless of fault.

I understand agree that no oral or written representation can or will alter the contents of this document and I agree that this agreement shall be governed by the laws of State of Ohio.
